

THIS INGRAM MICRO SFTP TRANSFER AGREEMENT ("Agreement") dated and effective as of the date of signature is by and between **Ingram Micro** ("Ingram Micro"), with its registered address at CBXII West, Midsummer Boulevard, Milton Keynes, MK9 2EA, and you the customer ("Licensee").

Ingram Micro SFTP ("Secure File Transfer Protocol") is an Ingram Micro e-commerce solution allowing electronic business process and system integration with trading partners. Ingram Micro SFTP is a proprietary tool that allows the Licensee to obtain from Ingram Micro product catalogue and pricing, back order reports, and ship confirmation reports.

In consideration of the mutual promises contained herein, Ingram Micro and Licensee agree as follows:

1. Information and Software Defined. Ingram Micro shall provide to Licensee product pricing, descriptions and/or availability information in the form of SFTP electronic reports, any and all such agreed upon information and reports or parts thereof which pertain to the Licensee and set-up documentation, hereinafter referred to as the "Information".
2. License to Use. Ingram Micro hereby grants Licensee a limited, non-exclusive, non-assignable license to use Ingram Micro SFTP, the Information and any software for Licensee's internal sales and pricing analysis and/or to provide price (cost) and availability information for use only in price and availability queries and/or purchases from Ingram Micro and for no other purpose. All Information will be sent to Licensee via an SFTP file.

Notwithstanding the above, the Licensee may assign its right to use the Information and any software to a 3rd party, independent consultant with whom it has contracted, provided that Ingram Micro is notified of Licensee's intent to sub-license the Information or software and Ingram Micro grants such assignment in writing.
3. Term and Termination. The term of this Agreement shall commence on the date indicated above and shall continue until Licensee ceases to be a customer of Ingram Micro, subject to Ingram Micro's right to terminate this Agreement at any time upon thirty (30) days written notice, or immediately upon Licensee's breach of this Agreement. Upon termination, Licensee agrees to immediately return all Information and/or software, including any copies thereof regardless of form, to Ingram Micro, or if Ingram Micro so requests, to certify to Ingram Micro that all Information and software and copies have been destroyed.
4. Copyright Licensee acknowledges that the Ingram Micro SFTP, Information and any software are the property of Ingram Micro and that the granting of a license to use Ingram Micro SFTP, the Information and any software hereunder shall in no way constitute or be construed as a grant of any proprietary interests or copyrights in the Ingram Micro SFTP, the Information or any software. Licensee agrees that it will not copy, scan, duplicate or reproduce any of the Information or any software in any manner whatsoever, except that Licensee shall be permitted to create additional copies of the Information for its internal use only and as permitted under Section 2.
5. Non-disclosure. Licensee agrees to hold in confidence and not to directly or indirectly use, reveal, report, publish, disclose or transfer to any other person or entity any of the Information, or utilize any of the Information or software for any purpose at any time except as permitted under Section 2. Licensee shall have the right to disclose the Ingram Micro SFTP and Information to employees of Licensee and any Ingram Micro authorized independent contractor to the extent necessary to perform tasks directly related to the permitted uses; provided, however, that the Licensee shall take steps to ensure that such persons conduct themselves so as to preserve the confidentiality of the Information and any software, whether or not such Information and software is marked as confidential. The obligations stated in this Paragraph 5 shall survive the termination of this Agreement for a period of two (2) years.
6. Remedy In Event of Unauthorized Disclosure or Use. Because of the unique and proprietary nature of Ingram Micro SFTP, the Information and software, it is understood and agreed that Ingram Micro's remedies at law for a breach by Licensee of its obligations under this Agreement will be inadequate and that Ingram Micro shall, in the event of such breach by Licensee, be entitled to equitable relief (including, without limitation, injunctive relief and specific performance) without any requirement to post a bond as a condition for such relief, in addition to all other remedies under this Agreement or available at law.
7. Disclaimer of Liability. **INGRAM MICRO MAKES NO WARRANTY, EITHER EXPRESS OR IMPLIED ON INGRAM MICRO SFTP, THE INFORMATION AND ANY SOFTWARE. INGRAM MICRO SFTP AND ALL INFORMATION AND SOFTWARE ARE PROVIDED TO LICENSEE "AS IS". INGRAM MICRO HEREBY DISCLAIMS ANY AND ALL WARRANTIES, EXPRESS AND IMPLIED, RELATING TO INGRAM MICRO SFTP, THE INFORMATION AND ANY SOFTWARE INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTY OF MERCHANTABILITY AND THE IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE.**
8. Limitation of Liability. **UNDER NO CIRCUMSTANCES SHALL INGRAM MICRO BE**

LIABLE TO THE LICENSEE OR ANY THIRD PARTY FOR INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL OR EXEMPLARY DAMAGES (EVEN IF THAT PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES), ARISING FROM THE USE OR INABILITY TO USE INGRAM MICRO SFTP, THE INFORMATION AND ANY SOFTWARE, OR ANY OTHER PROVISIONS OF THIS AGREEMENT, SUCH AS, BUT NOT LIMITED TO, LOSS OF REVENUE, ANTICIPATED PROFITS OR LOST BUSINESS.

9. Indemnification. Licensee shall indemnify, defend and hold harmless Ingram Micro from and

This Agreement contains the full and complete understanding of the parties with respect to the subject matter hereof and supersedes all prior representations or understanding, whether oral or written.
